Stallion Service Contract

This contract made by and between Crooked Willow Farms ("Farm") and _____
("Purchaser") for the breeding of _____ ("Mare")

I. FEES: The Mare Owner agrees to pay the following.

A. A nonrefundable booking fee of \$300.00. The balance of \$1,400, must be paid before semen will be shipped. After March 1, 2010 the Stallion Service Fee is due at the signing and return of this contract. Mare Owner understands that the Mare must be examined by a licensed veterinarian 60 days after the last day bred and Crooked Willow Farms notified of her pregnancy status at that time.

B. A Stallion Service Fee of \$1700 representing one stallion service. Booking fee is included with the Stallion Service Fee.

ALL FEES AND COSTS MUST BE PAID BEFORE SEMEN WILL BE SHIPPED OR MARE BRED

IV. RESERVATION FOR SEMEN

Crooked Willow Farms receipt of the above fees confirms the Mare's booking to the Stallion for the ("Current Breeding Season"). All semen orders must be received by 8 AM MST/MDT the day of the requested collection date. Late orders will be filled if possible. Frozen Semen should be ordered at least one week before the breeding of the Mare.

VII. BREEDING PASSPORTS / DELIVERY CERTIFICATES

A. Mare owner will receive a "Mare Breeding Passport" which is to be filled out by a licensed veterinarian and returned to Crooked Willow Farms no later than July 30th of the breeding year.

VIII. BREEDING CERTIFICATES

A. A breeding certificate will be issued after the end of the breeding season. (**Breeding Season is April 1, 2010 to June 15, 2010**)

B. A copy of the Mare's breeding papers must accompany this contract in order to receive a breeding certificate at the end of the season. If your Mare has been "Approved" by a Sport Horse breeding registry please indicate that here: _____.

X. RETURN OF SERVICE.

The mare owner shall have the right of return to the Stallion's service in the following season only under the following circumstances:

- a. If the mare does not settle during the present breeding season, she is eligible for return of service to the stallion if the mare owner submits a veterinarian's certificate to that effect. The mare owner recognizes Crooked Willow Farm's right to require a negative intrauterine culture certificate prior to the mare's return to service.
- b. If the mare is examined in foal but becomes barren during gestation, she is eligible for return if Crooked Willow Farms receives a veterinary certificate of barrenness within thirty (30) days of the examination.
- c. If the Mare subsequently produces a live foal that is unable to stand alone and nurse, and subsequently dies, a veterinary certificate must be provided within five (5) days of death.
- d. If the Mare becomes unfit for breeding or otherwise unbreedable, purchaser may substitute another mare. Purchaser must request this change in writing.
- e. All rights of return to the stallion are subject to prepayment of costs set forth in section 1 above.

XI. REFUND OF FEES.

This contract shall be null and void and the Mare owner shall be entitled to a refund of any amount paid hereunder if the stallion should die, or become unfit for service prior to serving the mare in the present breeding season. The Mare owner shall have the option to substitute another Crooked Willow Farms stallion.

XII. LIABILITY.

The Mare Owner shall assume all responsibility for the condition of the Mare and shall bear all risk of loss or damage to the Mare, whether by death, disease, injury, infection or otherwise, and by any cause whatsoever, and therefore agrees to hold Crooked Willow Farms or any person associated with Crooked Willow Farms harmless for any and all damages associated therein.
