### *Stallion Service Contract*

This contract made by and between Crooked Willow Farms ("Farm") and \_\_\_\_\_ ("Purchaser") for the breeding of \_\_\_\_\_ ("Mare") to Chaleon ("Stallion") for the 2012 Breeding Season ("Current Breeding Season"); subject to the following terms and conditions:

#### **I. FEES:** The Mare Owner agrees to pay the following.

A. A nonrefundable booking fee of \$250. The balance of \$750, must be paid before semen will be shipped. After March 1, 2012 the Stallion Service Fee is due at the signing and return of this contract. Mare Owner understands that the Mare must be examined by a licensed veterinarian 60 days after the last day bred and Crooked Willow Farms notified of her pregnancy status at that time.

B. Collections. \$175. Regular collection days are **Monday, Wednesday, Friday** for delivery Tuesday, Thursday, Saturday. Same day counter to counter service is also available on collection day and Saturdays thru the airlines thereby enabling most breeders to receive shipments any day of the week except Sundays.

C. Shipping. Fed Ex Priority shipments are billed at cost and vary depending on date of delivery and location. Average cost is \$150. Same day counter to counter service thru the airlines is \$100 plus a courier fee of \$125 to take shipments from Premier Breeding Services to Denver International Airport.

#### **ALL FEES AND COSTS MUST BE PAID BEFORE SEMEN WILL BE SHIPPED OR MARE BRED**

#### **IV. RESERVATION FOR SEMEN**

Crooked Willow Farms receipt of the above fees confirms the Mare's booking to the Stallion for the ("Current Breeding Season"). All semen orders must be received by 8 AM MST/MDT the day of the requested collection date. Late orders will be filled if possible. Frozen Semen should be ordered at least one week before the breeding of the Mare.

VII. BREEDING PASSPORTS / DELIVERY CERTIFICATES

- A. Mare owner will receive a "Mare Breeding Passport" which is to be filled out by a licensed veterinarian and returned to Crooked Willow Farms no later than July 30<sup>th</sup> of the breeding year. **BREEDING SEASON IS May 1st to June 30<sup>th</sup>.**

VIII. BREEDING CERTIFICATES

- A. A breeding certificate will be issued after the end of the breeding season.
- B. A copy of the Mare's breeding papers must accompany this contract in order to receive a breeding certificate at the end of the season. If your Mare has been "Approved" by a Sport Horse breeding registry please indicate that here: \_\_\_\_\_.

XI. REFUND OF FEES.

- A. This contract shall be null and void and the Mare owner shall be entitled to a refund of any amount paid hereunder if the stallion should die, or become unfit for service prior to serving the mare in the present breeding season. The Mare owner shall have the option to substitute another Crooked Willow Farms stallion.

XII. LIABILITY.

The Mare Owner shall assume all responsibility for the condition of the Mare and shall bear all risk of loss or damage to the Mare, whether by death, disease, injury, infection or otherwise, and by any cause whatsoever, and therefore agrees to hold Crooked Willow Farms or any person associated with Crooked Willow Farms harmless for any and all damages associated therein.
